GENERAL NOTES:-**1.0 Payment of Fees**

- 1.1 All fees are DUE upon REGISTRATION and shall be made on the 1st day of registration each Term.
- 1.2 Tuition Fee is charged according to each Term. The details are as follows:-

- Term (January / April / July / Oct)	3,460

However, if the student is unable to complete within a time frame of (12) Terms, additional Tuition Fee will be charged at RM1,750 per Term to a maximum of twenty four (24) Terms.

- 1.3 Registration Fee and Lab Fee are chargeable one-time only and shall be paid together with other fees on the 1st day of Registration of the 1st Term. Insurance is payable annually.
- 1.4 Replacement of Student Card shall be charged at RM20 each.
- 1.5 Convocation fee of RM280 is chargeable (optional) only when a student decides to attend Convocation.
- 1.6 Payment shall be made by: -
 - Cash, or
 - Bank draft / Money Order / Postal Order / Cheque made payable to **Ikram Education Sdn Bhd.** (Please include 0.3% Commission for outstation cheque / Bank draft / Money Order / Poster Order) , or
 - VISA / MASTER credit card or BANKCARD "e-Debit" Card at KLIUC, or
 - Online Bill Payment Services via **maybank2u.com.my OR rhbbank.com.my** under the Payee Corporation Name OR Manage Biller List "**KL Infrastructure Univ. College**" respectively.

2.0 Refund Policies

- 2.1 Processing Fee is payable upon submission of the completed application form and is non-refundable.
- 2.2 Registration Fee and Lab Fee are non-refundable.
- 2.3 60% of the Tuition Fee is refundable by submitting the "Withdrawal Form" within 14 days from the 1st day of Registration for each intake. 80% of the Tuition Fee will be refunded if the student withdraws before the 1st day of Registration. In both cases, the withdrawal must be approved by the Management.
- 2.4 Deposit is refundable upon submission of the completed Form after graduation or withdrawal whichever is earlier. KLIUC reserves the right to recover any outstanding amount owed by a student and will utilise the deposit for partial or full settlement of any outstanding amount.
- 2.5 The payment of refund shall be made within 60 days from the date of submission of the completed "Withdrawal Form" by a student.

3.0 Late Payment

- 3.1 Late payment shall be subject to a penalty payment of RM10 for the 1st day and RM5 daily thereafter when fees are overdue.

4.0 Others

- 4.1 Fees are in Malaysia Ringgit (RM) unless otherwise stated.
